6 Planning Applications

6.1 22/03847/APP – 39 Prospect Place, Wing

Householder application for proposed first floor side extension and dormer extension.

Resolved: To offer No Objection to this application.

6.2 22/03952/APP - 5 Sirett Close, Wing

Householder application for car port conversion and single storey front/side extension.

Resolved: To submit an Objection to the planning application as we support our Neighbourhood Plan which states three parking spaces are required for this size property however we understand there are mitigating circumstances around this application.

6.3 22/03959/APP - 10 High Street, Burcott

Householder application for single storey side/rear extensions with raising of existing roof line, hip to gable roof alteration insertion of roof lights and insertion of a first floor flank window to create additional accommodation at first floor level, together with alterations to the fenestration (amendment to approval 22/02111/APP).

Resolved: To submit an Objection to the planning application on the same grounds as last time covering scale, overbearing, loss of privacy and insufficient parking with an additional comment to say that in the event that the planning application is recommended for approval it is called-in to Committee.

6.4 22/00170/ENFNOT – Mount Pleasant Farm, Burcott

Appeal against without planning permission the material change of use of the land to 5 single residential units facilitated by the erection of decking, a balcony and a roof extension.

Resolved: To submit comments supporting the enforcement document.

6.5 22/00174/ENFNOT – Mount Pleasant Farm, Burcott

Appeal against (1) without planning permission the material changes of use of the land to a mixed use of residential, equestrian, agriculture, the sale, display and storage of motor vehicles and the storage of materials: and (2) Operational development consisting of the laying of hardstanding.

Resolved: To submit comments supporting the enforcement document.

7 Recreation Ground Improvements Project

To receive a written report on the progress of the project including any recommendations on actions required at this stage for Council consideration.

A verbal report was provided by Councillor Sunday with an update on the recreation ground improvements project, this included submitting the information to claim the FCC grant funds, a security bush is to planted around the perimeter of the pavilion (but not in front of the hatch), there is still work required to complete the pavilion and the groundworks. The work to install the MUGA is scheduled to start week commencing 16th January. UKPN are still wanting to pass the 3-phase supply over to larger projects so we are looking at alternative suppliers whilst working with UKPN.

The pv panels will be supplied and installed by Cawoods at a cost of £13,994.66 (inc VAT) which is a reduction in the amount previously approved for pv panels by the Council.

Resolved: To pay a 25% deposit on order to Sports Courts towards the trenching works.
