# **Business To Be Transacted At The Meeting**

#### 1 Chair of the Council's Welcoming Statement

Councillor Sunday welcomed everyone to the meeting.

## 2 Public Participation

- 2.1 There were no comments made during Public participation.
- 2.2 Councillor Bond gave a verbal report to the meeting on:
  - The Wing and Ivinghoe Community Boards latest meeting and the ways they are looking at to increase attendance from the public.
  - The Wing Caravan Site had been appealed by the applicants to the High Court and it has been passed back to the Planning Inspectorate by Judicial review.

Councillor Blamires gave a verbal report to the meeting on:

- The enforcement decisions for Mount Pleasant Farm have been upheld by the Planning Inspectorate following the applicants appeal.
- Following the resurfacing of Wing High Street in November, there has been positive feedback received.
- Soulbury Road will be resurfaced next year.

Councillor Cooper gave a verbal report to the meeting on:

- Additional information on the Wing Caravan site as to what the process will be is unclear. The planners
  are checking whether new comments can be made or if the previous comments made will be the ones
  considered.
- 5 Aylesbury Road had a planning application refused by the Heritage department but the owners are looking to resubmit an application for a driveway around the side of the house and better access to the garage as it is very tight.

The Clerk confirmed notification had not yet been received.

Councillor Kellner asked the Unitary Councillors to chase the Skewkley Road bridge repair following an accident.

Councillor Sunday also verbally reported that Anglian Water were onsite behind the Recreation Ground as non-flushable items are building up and blocking the pipeway.

Councillor Tring provided a verbal report on activities since last meeting including a walkaround the Woodlands with Goldleaf Groundcare and the Clerk to confirm the areas included in the contract and the work required.

6.3 23/03548/APP – Acorn Farm, Cublington Road, Wing

Resolved: To submit a 'No Objections' comment for planning application 23/03548/APP.

6.4 23/03600/APP – The Cottesloe School, Church Street, Wing

**Resolved:** Delegated authority is given to the Clerk to submit an objection comment for planning application. The draft wording will be supplied by Councillors Davidson and Lomas containing objections regarding the removal of trees/ shielding and no provision for additional parking for drop-off and pick-up parking problems but that the Parish Council would support a revised plan that provided mitigation for the parking issues on the roads surrounding the school in accordance with the Neighbourhood Plan.

At this point in the meeting Councillors Sunday and Kellner returned to the meeting.

#### 7 Recreation Ground Improvements Project

- 7.1 A verbal report on the progress of the project was provided and included information on the remedial work Healthmatic need to carry out.
- 7.2 **Resolved:** To defer considering the changes to the electrical connection quote as extra work is required as not all the information has been received.
- 7.3 **Resolved:** To instruct the ground care contractor to prepare and reseed outside the pavilion.

#### 8 Bike Racks

Councillor Gilbert provided information on the project to install bike racks around the parish and suggested applying for grant funding with matched funds from the Parish Councils budget.

**Resolved:** To accept the project for installing bike racks around the parish.

**Resolved:** To apply to the Community Board for £1,000 of funding and use up to £1,500 from the Environment Group General Budget for the project.
